Acceptance for enrollment in South Alabama Christian School is at the discretion of the School Board and is based upon the satisfactory completion of all application requirements as outlined in the application material. **All applicants must be in good standing with all previous schools of attendance and legal officials.** The School Board will consider each case on its merits and weigh the facts and circumstances in each applicant's situation in making the decision for enrolment . However, the School will not at any time accept a situation which we believe will not preserve the best interests of the School and to the families already legally and peacefully enrolled with the School.
